Welcome to the MILTRADERS website (the "Site" or the "Website"). These Terms of Use (hereinafter the "Terms", "TOU", or the "Agreement") govern your access to and use of the Site operated by MILTRADERS LLC-FZ, a United Arab Emirates Limited Liability Company with its registered office located at Meydan Free Zone, Dubai, United Arab Emirates (hereinafter "MILTRADERS", "we", "our", or the "Company").

BY ACCESSING OR USING THE SITE IN ANY MANNER WHATSOEVER, YOU ACCEPT AND AGREE TO BE BOUND BY THESE TERMS OF USE IN THEIR ENTIRETY. If you do not accept these Terms, please do not use, access, or consult the Site.

Please note that access to certain portions, sections, or functionalities of the Site is reserved, restricted, and limited to users who have opened a MILTRADERS account and who have accepted and electronically signed the Evaluation Agreement (MILTRADERS Challenge Agreement) or the Funded Account Agreement (MILTRADERS Funded Account Agreement), as applicable.

ARTICLE 1: LIMITED USE LICENSE

1.1 Grant of Non-Exclusive License

You are hereby granted a limited, non-exclusive, non-transferable, revocable at any time by MILTRADERS without notice, and personal license to use, consult, and navigate the material, content, information, and pages available on this Site, but only within the framework of your personal access to the Site and for your strictly personal, private, and non-commercial use.

You may browse, consult, and read the publicly accessible pages of the Site for purely informational, educational, and discovery purposes of our Services.

1.2 License Restrictions and Limitations
